



## 2017 Oktoberfest Ride ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, public infrastructure, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. I acknowledge that the roads on the route have potholes, cracks, loose gravel, and other deficiencies. These risks are not only inherent to athletics, but are also present for volunteers and staff. I hereby assume all of the risks of participating, working, and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person. I acknowledge that alcohol is available at the post ride festivities. Should I consume any, I agree to consume it responsibly, and to operate my vehicle only in a safe and lawful manner, and not under the influence of alcohol.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by the event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event, **THE FOLLOWING ENTITIES OR PERSONS:** All governmental agencies including, **BUT NOT LIMITED TO:** Commonwealth of Pennsylvania, Montgomery County, Bucks County, Borough of Collegeville, Lower Providence Township, Skippack Township, Lower Salford Township, Upper Salford Township, Marlborough Township, Upper Frederick Township, New Hannover Township, Upper Hannover Township, Milford Township, Salford Township, Franconia Township, Bicycle Ride Directors Association of America, Kermesse Sport LLC; Boy Scouts of America, Collegeville Fire Company, Appalachian Brewing Company, Collegeville Station LLC, and their respective directors, officers, employees, contractors, volunteers, representatives, and agents, the event owners, event sponsors, event directors, event staff, event volunteers, and co-participants; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this event.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and or illness during this event. I understand that at this event or related activities, I may be photographed, videoed, filmed or otherwise have my likeness, voice or a combinational recorded. I agree to allow my photo, video or film or sound likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and/or assigns.

This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
